



Anti-Slavery Statement

This statement is made pursuant to s.54 of the Modern Slavery Act 2015 and outlines the steps that Grimme UK Ltd has taken, and continues to take, to ensure that modern slavery and human trafficking are not taking place within our business or supply chains.

Our Commitment

Modern slavery is a crime and a violation of fundamental human rights. It involves the deprivation of a person's liberty by another in order to exploit them for personal or commercial gain. Modern slavery encompasses slavery, servitude, human trafficking and forced labour. Grimme UK Ltd are fully committed to acting ethically, transparently and with integrity in all our business dealings and relationships to ensure modern slavery is not occurring within our business or in our supply chains.

Our Policies and Procedures

Supply Chain

Generally our supply chain is relatively streamlined as most of our products are sourced from our manufacturing parent company based in Germany, which operates with the utmost integrity, professionalism and high standards. We do not support or engage with any business that we suspect may be involved in slavery or human trafficking.

Recruitment & Employment

In 2022 we recruited a dedicated full time HR Business Partner to assist with HR related matters and ensure stringent adherence to our policies. We conduct robust checks on new employees to confirm eligibility to work in the UK and safeguard individuals from being forced to work against their will.

Key Measures adopted in 2024 include:

Verification of staff passports and bank details to ensure eligibility to work in the UK and direct payment to individuals rather than a third party.

All recruitment and job finding fees to be paid by the business and under no circumstances by the applicant. When using third parties to source staff we would verify it is not their policy to charge applicants a job finding fee.

Compliance with minimum and living wage legislation.

Implementation of online training for all employees since 2023, educating them on recognising and reporting modern slavery. New employees also undergo this training.

We are committed to continuously improving our policies and procedures to prevent modern slavery and human trafficking and will aim to take further steps during 2025.


